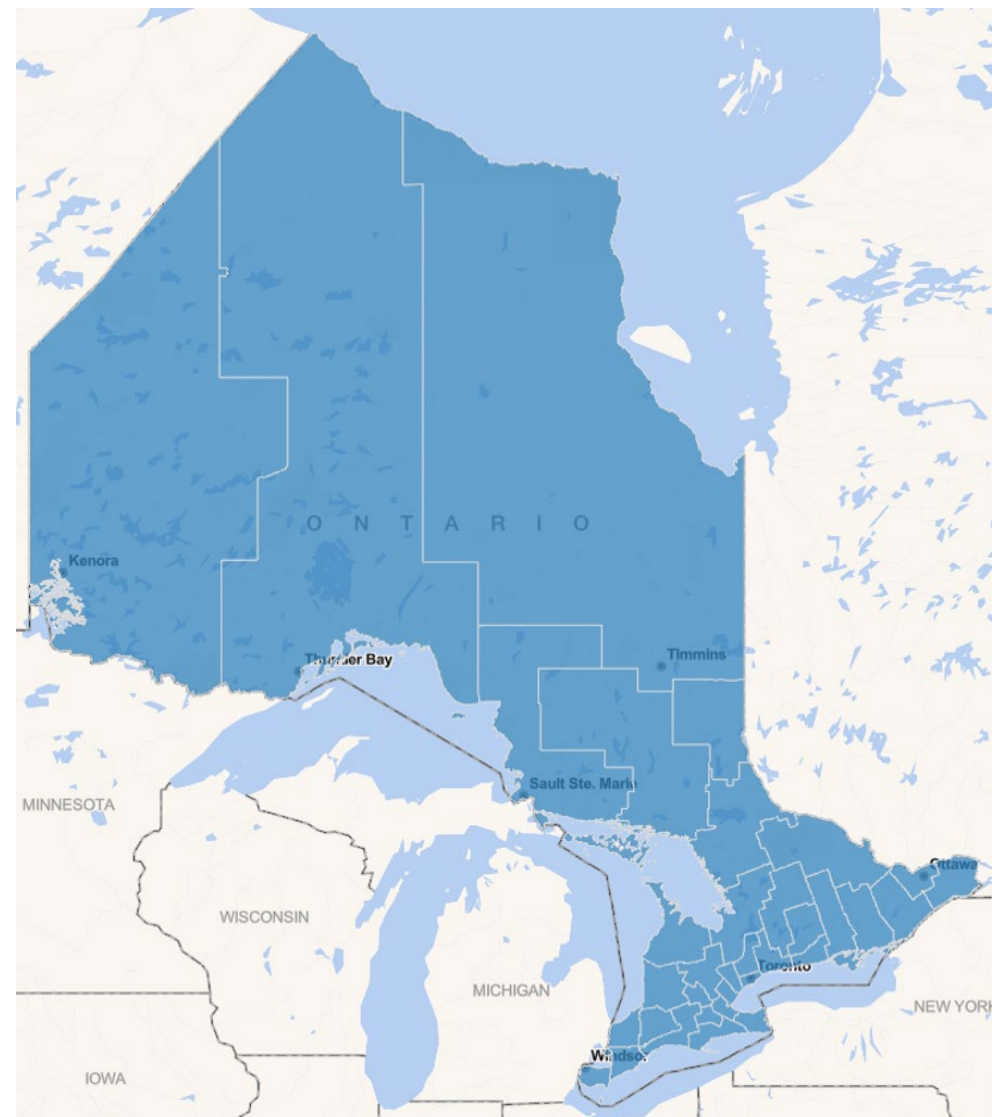

Role of Research Ethics Coordinator (REC)

- Liaise with applicants, ERB members and Chair
- Coordinate project submission process, assignment of reviews
- Assist with education and training sessions
- **Primary contact for submissions and questions or concerns**

Role of Research Ethics Officer (REO)

- Conducts low-risk reviews on behalf of the ERB
- Conducts pre-review (including RST validation) of all ERB submissions to ensure that they are complete and comprehensive
- Develops resources and tools
- Manages education and training sessions
- Provides ethics consultations
- **Primary contact for ethics consults and PHU capacity building initiatives**

PHO's Ethics Review Board (ERB)

- Receives administrative support from PHO's Ethics Services team
- Independent in its operations and decision making
- Compliant with national research ethics standards (*Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans (TCPS 2) 2022*)¹
- Members are selected from a variety of organizational settings and geographical regions across Ontario
- Members represent a range of methodological expertise in public health

Ethics Review Board

Our Ethics Review Board (ERB) reviews projects conducted on behalf of Public Health Ontario and Ontario's public health units.

The ERB is an independent board that includes members who are public health professionals and researchers from PHO and other public health, health care and academic organizations. Collectively, ERB members have expertise in a broad range of public health disciplines and methodologies, ethics, law, and community perspectives.

The ERB helps to ensure that projects are consistent with the **Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans, Second edition (TCPS 2)**, PHO's **Framework for the Ethical Conduct of Public Health Initiatives**, as well as other relevant regulations, policies and guidelines. The ERB has the authority to approve, reject, propose modifications to or withdraw approval of any eligible projects submitted for review.

The ERB also participates in the development of best practices for addressing emerging ethical issues in the conduct of public health evidence-generating initiatives across the province.

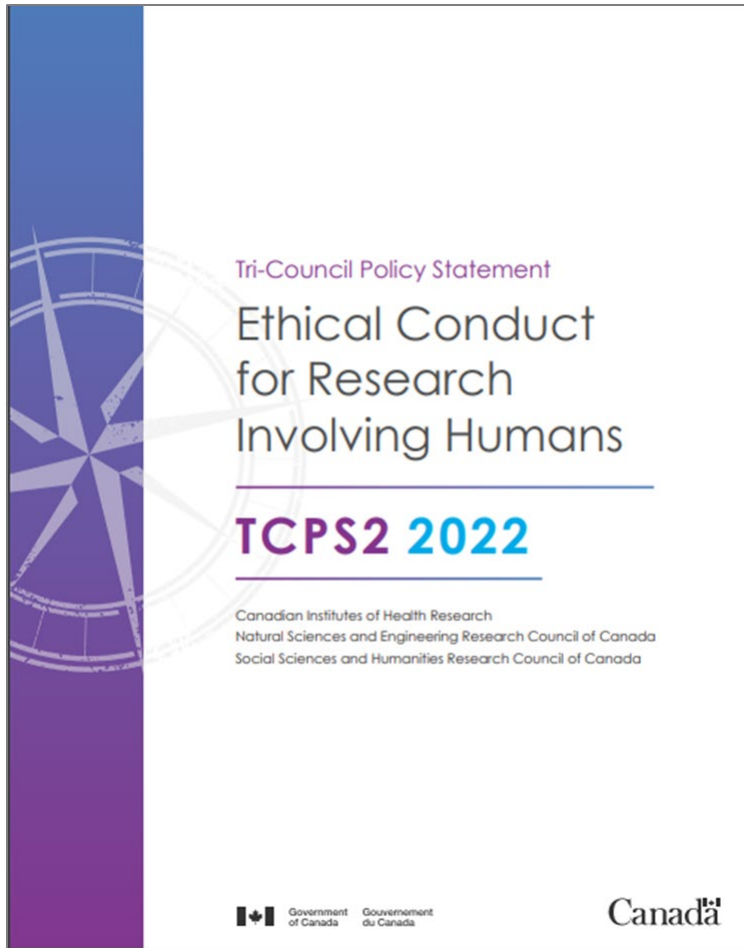

PHO's Ethics Review Framework and Model



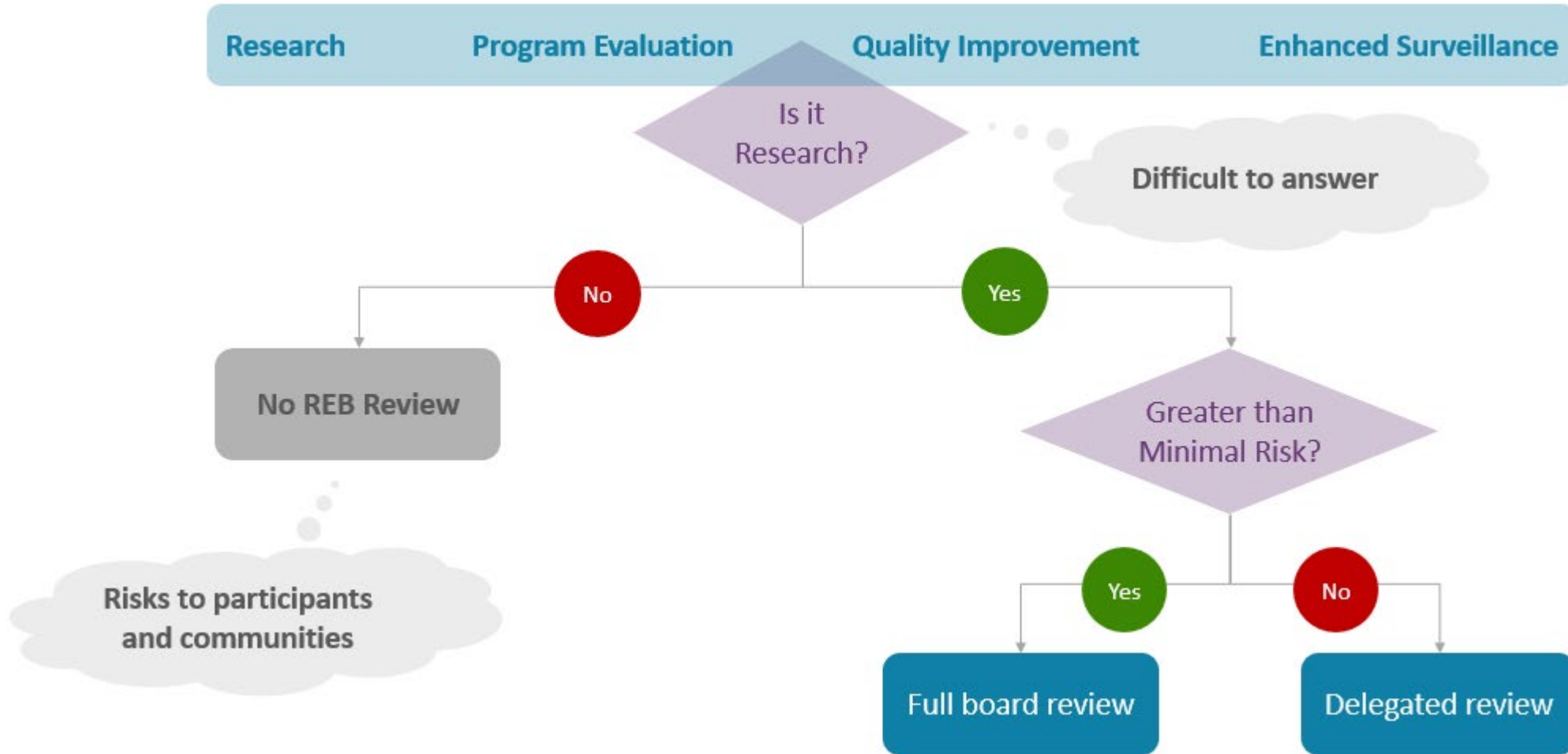

Traditional Approach to Ethics Review

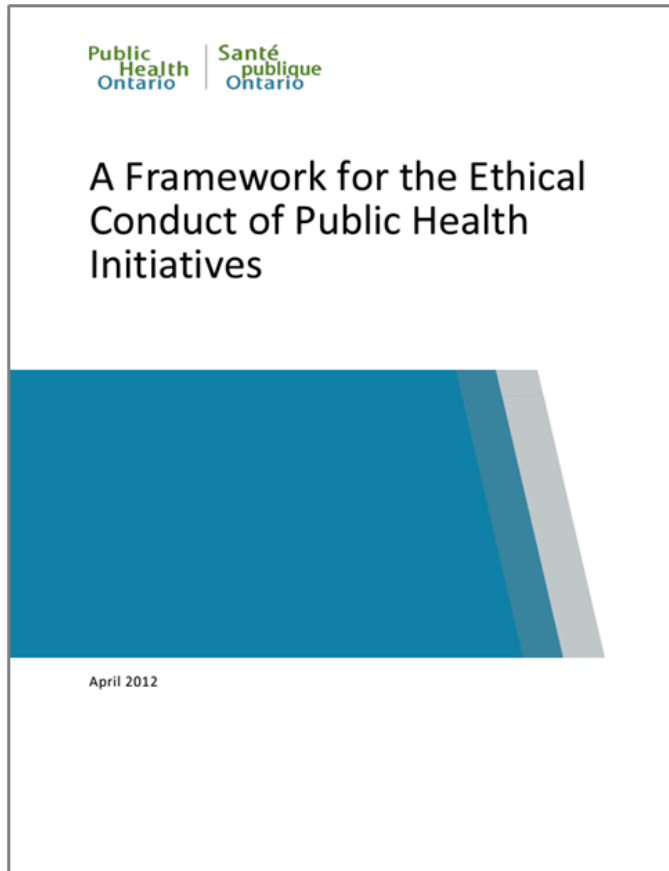


PH Evidence-Generating Activities



- All involve systematic collection of information to extend knowledge and inform action
- Use Similar Methods:
 - Surveys
 - data analysis
 - Interviews
 - Focus groups

The Framework



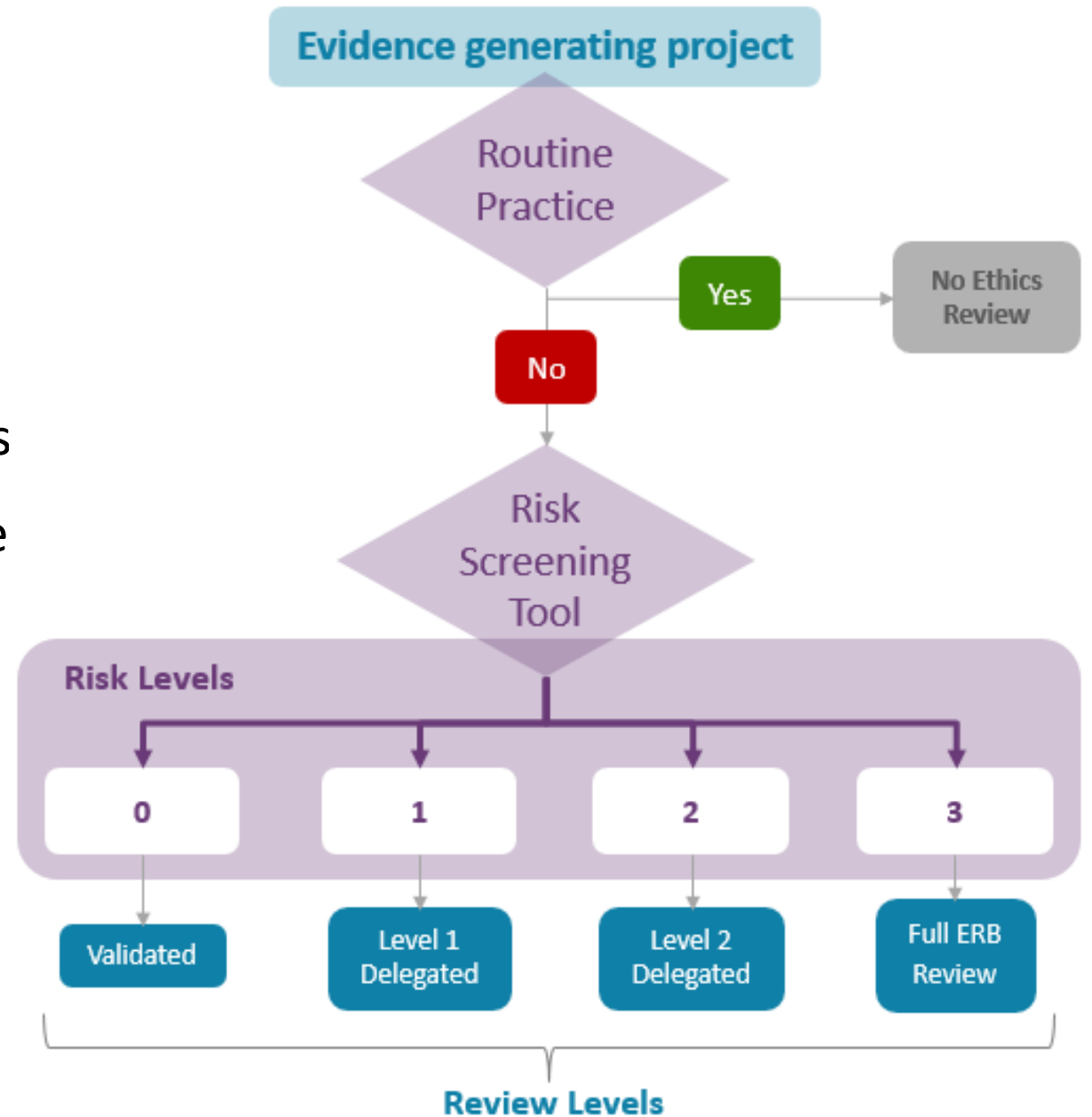
- “TCPS 2 plus”
- meets the requirements of relevant laws and policies
- all evidence-generating initiatives receive ethical scrutiny, proportionate to risk
- emphasis is on ethical integrity (what should we do) instead of compliance (what do we have to do)
- incorporates a population and public health perspective

PHO's Risk Screening Tool

Purpose:

- 1. Promote ethical reflection
- 2. Support systematic consideration of risk
- 3. Sort projects proportionate to risk level

Ethics Review and Oversight Services

- TCPS 2-compliant review of evidence-generating projects
- A single, centralized ethics review for projects involving multiple PHU

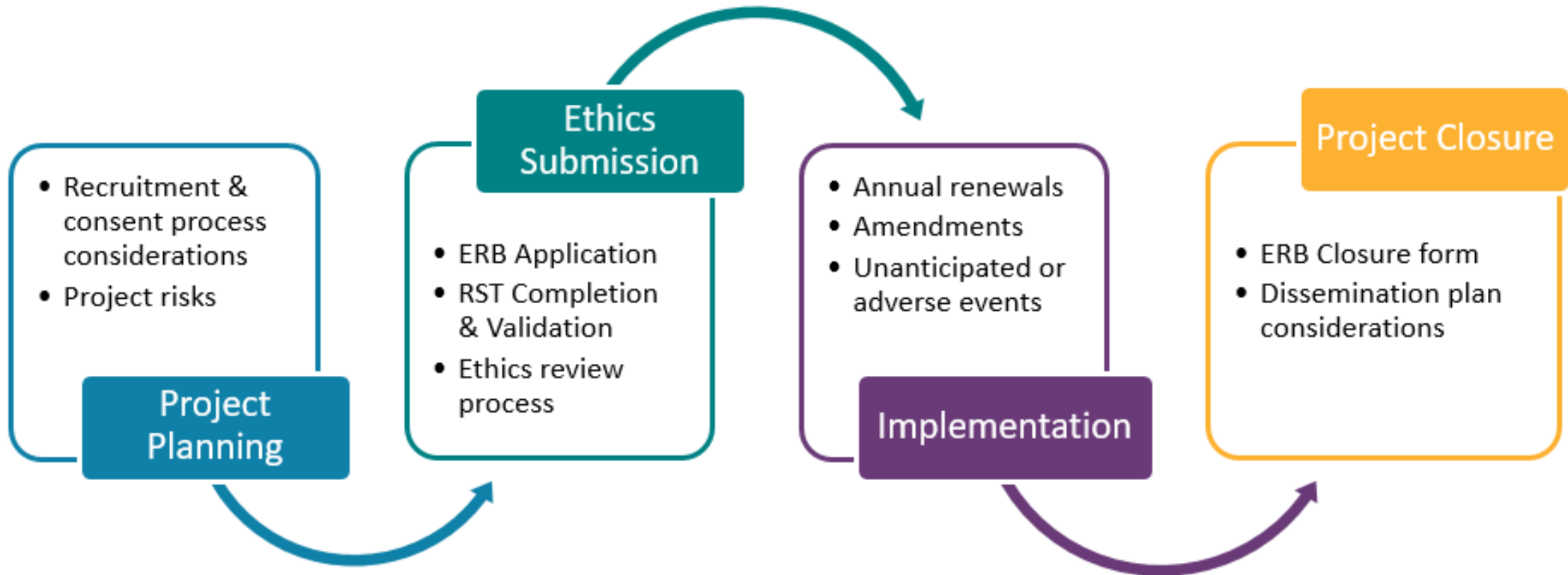


Capacity Building and Support Services

- Ethics consultations on project-related issues
- Support to develop capacity in the assessment of ethical risks and review of low risk projects
- Ongoing education and training
- Access to resources

When to Use PHO Ethics Services?

Throughout the life-cycle of your project:



Ethics Review and Oversight Services

- TCPS compliant review of any evidence-generating projects with a validated level 2 or 3 RST score
- Includes level 1 projects or administrative reviews that require a TCPS 2 compliant ethics review, e.g.:
 - Sponsor/funder requirements (e.g. Locally Driven Collaborative Projects)
 - Privacy requirement (e.g., PHIPA section 44 disclosure)



Board of Record Agreements

To use PHO's ethics review services, PHUs are required to have a **Board of Record agreement (BOR)** with PHO's ethics board

- PHU's are responsible for determining which projects will be submitted to PHO
- Use of PHO's ERB for any given project is completely optional
- Refer to our website for current list of 26 PHUs that have a BOR agreement with us

Multi-Site Projects

- Multi-site review board: a single, centralized ethics review board for projects involving multiple PHUs

Ethics Designate (ED)

- PHU's assign an ED when signing a BOR agreement
- The ED role is evolving and flexible and will depend on PHU capacity and service needs
- Expectations of the role (NOT requirements) include:
 - Liaise with PHO Ethics Services
 - Coordination of BOR agreement
 - Facilitating implementation and uptake of services
 - Capacity development

Examples:

- support completing risk screening tool
- consent and capacity issues
- ethical recruitment strategies
- community engagement plans
- identifying risks and mitigation strategies



Support to develop capacity in the assessment of ethical risks and review of low risk projects

- Co-review of low risk projects
- Advice on internal review processes
- Coordination of ethics designate forum/community of practice
- Access to resources and tools for the review of low-risk projects

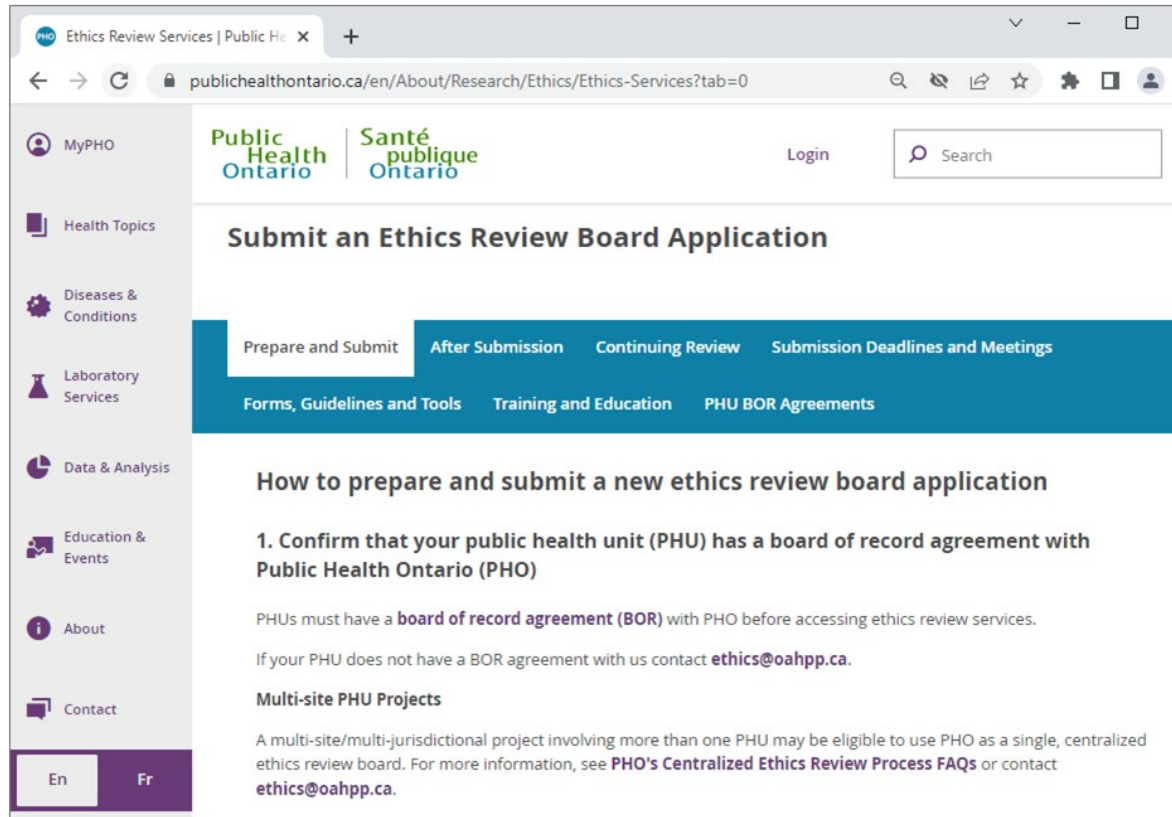

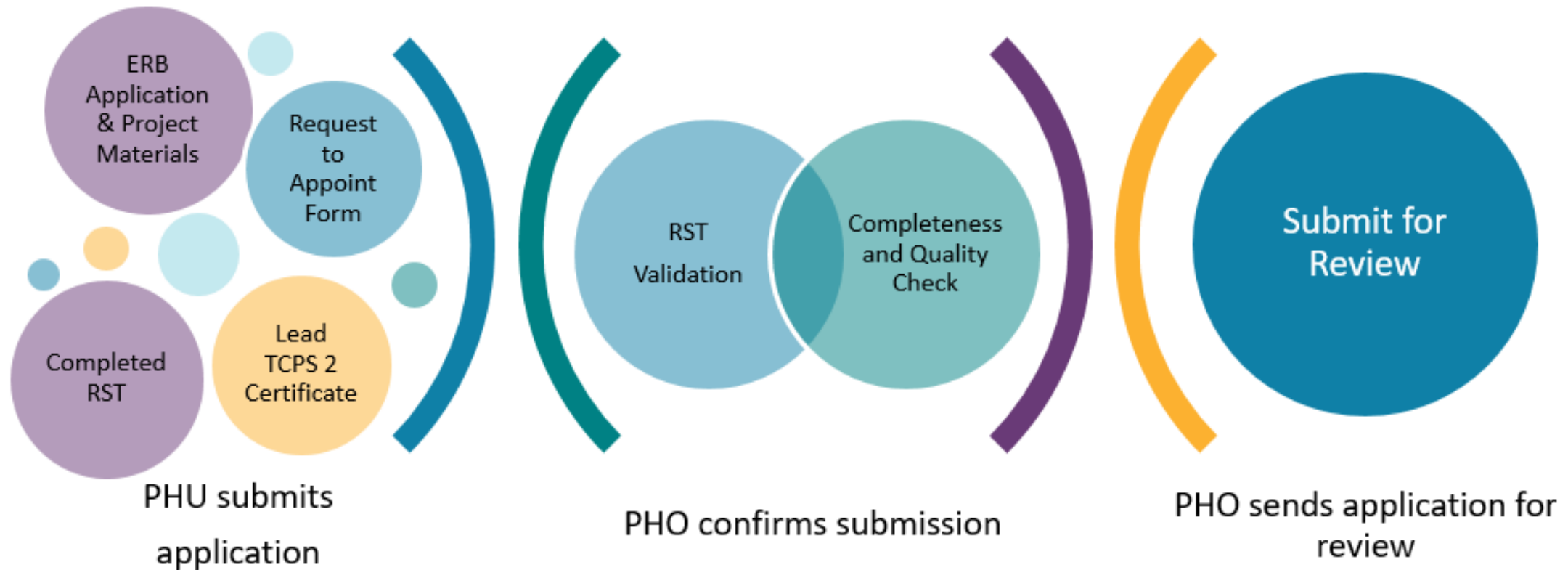

What makes a quality application?



Complete and Comprehensive Application



Scientific or Methodological Quality Review (E.2)

Methodological quality review should be conducted:

- By individual(s) with relevant methodological knowledge and experience who is separate from the project team
or
- Through a competitive review and approval process through an external granting agency (e.g. peer review committee such as LDCP)
or
- By existing internal PHU review committee



Privacy Review (E.3 in Application Form)

- PHU is expected to follow their internal policies regarding privacy review and explain these clearly in the ERB Application Form
- If working with external vendors or services then those agreements will have privacy aspects that should be included in the Application

Request to Appoint Form

- Found on the last page of the application form
- Signed by someone with signing authority for the unit (same requirement as BOR)
- Names PHO ERB as the BOR for the project
- Confirms that PHU considers project to be feasible and methodologically sound
- Obligates the unit to PHO ERB's decisions and continuing review requirements for that project

Ideally, ED has a supporting role throughout the submission and continuing review phases.

How Long Do Reviews Take?

Level Two Delegated Review

- 3-4 weeks from when complete application is received

Level Three Full Board Review

- 5 weeks minimum from the submission deadline (listed on our site)
- Level 3 reviews are tied to monthly board meeting dates
- If a project is submitted but it is not complete or ready to review at the deadline then it will be scheduled for the next month's board meeting
